DO NOT have your fingerprints made until you receive an email from AREC authorizing you to do so.






Complete the AREC Application for Real Estate Examination

YOU WILL NEED TO:

- 1. COMPLETE THIS APPLICATION (you are highly encouraged to use the fillable pdf form that was emailed to you)
- 2. PRINT IT (do not sign it yet!)
- 3. HAVE IT NOTARIZED
- 4. SIGN IT (you will sign in the presence of the notary)

Why complete it using the fillable pdf?

You will be notified <u>via email</u> on how to access the Background Portal. If your handwriting isn't legible for your <u>email address</u> and <u>DOB</u>, or, interpreted incorrectly, you might not receive the email that begins the "background check" process. Also, those two items are necessary to log into the portal to begin the criminal background check process.



In order to start the state and federal criminal background check process, the AREC will email you information on how to access the "Background Portal" to complete the Criminal Background Check (CBC) form and make an online payment for the background check fee. Privacy Act Statement Privacy Act of 1974, 5 USC § 552a

Authority: The FBI's acquisition, preservation, and exchange of fingerprints and associated information is generally authorized under 28 U.S.C. 534. Depending on the nature of your application, supplemental authorities include Federal statutes, State statutes pursuant to Pub. L. 92-544, Presidential Executive Orders, and federal regulations. Providing your fingerprints and associated information is voluntary; however, failure to do so may affect completion or approval of your application.







Make sure you <u>sign</u> the certificate before submitting





Make a copy of <u>ALL 5</u> <u>items</u> and submit to AREC

- ☐ Application for license examination
- □ Background Check Acknowledgement (BCA) form
- \$50 cashier's check or money order payable to AREC
- ☐ Copy of proof of age of majority
- ☐ Copy of Certificate of Completion from Vivid (name on certificate must match your driver's license)





WHAT HAPPENS NEXT?

The next steps to the right are for AR Residents only!

Non-residents will need to use a paper fingerprint card which you can get from the Arkansas Real Estate Commission.

Please refer to the AREC website for the fingerprinting process for non-residents.

ONCE AREC HAS RECEIVED ALL 5 ITEMS:

- Applicant will receive an <u>email</u> from AREC with info on how to access the Background Check Portal
- 2. Applicant will make an online payment via the Background Check Portal for \$36.25 plus a small processing fee.
- 3. Applicant will contact a certified fingerprint harvester or live scan operator for collection of fingerprints. (lists located in the white envelope received from Vivid)
- 4. The fingerprints are collected and submitted electronically to the Arkansas State Police (ASP) by the entity who collected your fingerprints.
- 5. Arkansas State Police will provide state and federal background reports to AREC.
- 6. Once all steps above are completed, applicant will receive an email from Pearson Vue (real estate exam testing company) regarding how to register online to take the real estate exam. You will need to check your email frequently for this email (including SPAM and JUNK folders). The average paperwork processing time with AREC is 7-14 business days.
- 7. You will need to show valid identification when you enter the Pearson Vue testing location.
- **8. PLEASE NOTE:** You may receive your approval to take your exam before you receive your request to have your fingerprints made.




DID YOU PASS THE REAL ESTATE EXAM?

NEXT STEPS ONCE YOU PASS THE EXAM

- 1. If you passed your exam, the testing center will give you a printed score report.
- 2. You should **thoroughly** read the printed score report. There are additional forms **that must be completed.**





ADDITIONAL FORMS TO BE COMPLETED

CONTINUED: NEXT STEPS ONCE YOU PASS THE EXAM

- You <u>must</u> then log into your Pearson Vue account to print out and complete the remaining documents.
- 4. All documents **must** be signed as stated.
- 5. To then activate your license, the **Principal Broker** of the company you have chosen to work for **must** sign the forms.
- 6. The form must then be returned to the AREC with the \$75 license activation fee.

You will not be able to conduct real estate business until your physical (paper license) has been received by the Principal Broker.
